 - > Appoint & remove agency heads
 - Reorganize the bureaucracy
 - > Make changes in or reduce an agency's budget proposal
 - > Issue Executive Orders [example: President Truman's executive order to the DOD to integrate the US military
 - b) Congress:
 - Cut or reduce agency funding
 - Create or abolish agencies & departments
 - Investigate agency activities
 - Hold committee hearings
 - Pass legislation that alters an agency's functions [Example: Pendleton Act to limit spoils system and establish a merit based system with a competitive civil service exam]
 - c) The Federal Courts
 - > Through *judicial review* rule on whether the bureaucracy has acted within the law and the U.S. Constitution
 - > Rule on constitutionality of all bureaucratic rules and regulations

Essay #1

- 1) The laws of supply and demand form the backbone of our market economy. Answer all parts of the question below.
 - a) Define *supply and demand*.
 - b) Explain the relationship between supply and demand and the price of a good or service.
 - c) Choose a product or service that you have purchased or used recently (examples: new clothes, gasoline, iPhone, Duck Donuts). Using the example you choose, explain how the law of supply and demand works in the market place with this particular product or service. Include a separate discussion of the supply of the product, the public's demand for the product, and the price of item.

Essay #2

- 2) Americans often complain about paying taxes. At the same time, we have come to expect the government to provide important services to its citizens like public schools, retirement payments, highways, and a strong national defense. All of these programs or services cost money and are funded by taxes. Answer all parts of the question below.
 - a) Do you think our current personal income tax system is fair? Explain why or why not.
 - b) Identify what you think is the most important government program or service provided by the federal government, and explain why it should continue.
 - c) Identify what program or service you think is the biggest waste of government spending, and explain why it should be greatly reduced or eliminated.
